
4. **Definitions**


- a. Trust means "Muslim Jama Ath Educational Trust", Venjaramoodu.
b. Founder means "Muslim Jama Ath Educational Trust", Venjaramoodu
c. Financial Year means "Financial year from 1st April to 31st March of next year".

5. **Objects of the Trust**

- i. To establish and administer school, college and other Educational Institutions to impart and improve Education to Muslims and other backward and minorities.
ii. To run and administer the MAM Public School, established by the Trust improving and upgrading the said School in all respects.
iii. To establish and run Vocational Training Centers, Technical and Professional Institutions.
iv. To establish and run Research Institutions, Ancillary Institutions, Libraries etc.
v. To set up Libraries for improving the education and common knowledge of the people of State.
vi. To grant loans, awards, scholarships to deserving students.
vii. To receive and utilize donations for materializing the General Object of the Trust.
viii. To conduct Ventures like study tour, excursion, vacation study, campus seminars, exhibitions, etc.
